Background:

Lagos Building Investment Company PLC (LBIC) was established as a corporate entity on the 14th of February 1980 to provide Mortgage Finance Facilities to allottees of the various Low- Cost Housing Schemes built by the Lagos State Government (between 1979-1983). With the promulgation of the Mortgage Institution Act No.53 of 1980, the company became a full-pledged Primary Mortgage Bank (PMB). Subsequently, it extended granting of mortgages to the middle-income segment of the population.

LBIC is an accredited Primary Mortgage Bank (PMB) certified to operate in Nigeria by the Central Bank of Nigeria (CBN) and vastly experienced in the provision of mortgage banking services.
