

## Notes to the Accounts

### 1. Going Concern

This report has been prepared on a going concern basis. The Directors of Air Liquide Nigeria Plc have no intention or need to reduce its business operations. The management and shareholders have the intention to further develop the business of the company.

### 2. Revenue

Revenue represents the sales of manufactured and purchased goods from both local and international sources.

The revenue for the period includes sales of Gasses & related service and revenue from other activities such as sale of medical and welding equipment.

### **3. Cost of Sales**

Cost of sales for the period includes Cost of Raw material and consumables (from both local and International Sources), costs linked to employees directly related to the factory and other expenses.

### **4. Other Incomes**

This includes revenue not linked to our main activities such as the disposal of scrapped assets.

### **5. Other Operating Gains/(Expenses)**

Other operating Expenses include mainly depreciation of our assets (administrative and technical), provisions for obsolete and dormant inventories, provisions for bad debts, Royalties and technical fees, realized and non realized exchange loss/gain.

### **6. Administrative Expenses**

Administrative expenses include expenses engaged for rent and leasing of some locations (both in Lagos and Port Harcourt), maintenance and Installation of our Plants and buildings, Personnel expenses for administrative staff, professional fees, Insurance, communication and other administrative costs.

### **7. Finance Cost**

Finance costs include the cost of overdraft incurred and charged during the Period under review.

### **8. Property Plant & Equipments**

This includes all fixed assets held by the company : Land, buildings, Plant and machinery, workshop equipment and gas cylinders, furniture, computer equipment and air conditioners, motor vehicles and software.

### **9. Right of use Assets**

These include the cost of rental of facilities for both sales and operational purposes.

### **10. Tangible Assets In Progress**

This includes the cost of purchase and installation of new assets for production of gasses. The total amount would be capitalized on commissioning of the projects.

### **11. Inventories**

This includes the actual value of our Raw Material & Consumables and Finished & Semi Finished products kept in our various warehouses.

### **12. Trade & Other Receivables**

This is made up of current debtors such as Customers & Notes receivable, sundry debtors and prepaid expenses.

### **13. Cash & Cash Equivalent**

This includes available cash in the bank and on hand at the end of the period.

### **14. Other Payables**

This includes Customer liabilities (Guarantee deposit) and employee benefits liabilities.

### **15. Suppliers & Other Payables**

Suppliers & Other payables include mainly operating suppliers liabilities and assets suppliers liabilities.

### **16. Cash Generated from Operating Activities**

This involves adjustments for expenses charged but not involving movement of cash for the period under review.
